



1. - That government from time to shall have the right to inspect the start hospital (including the said beds therein which the manager are terminated to use) on behalf of the government and the manager are terminated staff and the student of the institute shall render to a let person assistance enable person inspect the said hospital if such person requires the Manager to comply with direction in this behalf has the Manager shall without demur comply with them.
